The IWRM Programme/Helvetas organized a virtual Eol pre-application conference on 3 July 2025 with the objective of explaining the contents of the Expression of Interest (Eol) documents and fostering a shared understanding among prospective NGO partners. During the session, Helvetas staff provided a detailed briefing on the Eol document to the representatives of interested NGOs. An open discussion followed, allowing for clarification of key points, and a common understanding of the Eol requirements was established between both parties.

The queries raised by the NGO representatives were addressed by Helvetas. The responses to queries received from prospective NGOs through email and during pre – application conference are compiled in the table below.

We hope this has been planned in the project staff structure, for the implementation of hygiene and sanitation related activities and community WASH awareness.	In the Eol, we have outlined only the key positions proposed for each partner NGO. However, we would like to clarify that there is provision for additional positions as required by the scope of work. The broader project staffing structure will include roles such as Community/Social Mobilizers, Sub-Engineers/Overseers, Field Technicians, among others. The specific positions and number of staff to be recruited will depend on
3	Assistant sub-engineers are essential for ensuring quality of the water supply schemes. 6	In the section 2.7 ,2.8 there is required to tick as yes/no response or need to write description details?	In section 2.7 and 2.8 of the EoI form 2, just write Yes or No as applicable. In the explanation / remarks column, provide further information / explanation about that activity / provision, which you think relevant for evaluation of your application. If any cell does not require further explanation, it may be left blank.
7	In the 2.10.2 there is seeking the information of partner WASH related experienced during last five year, So, we have some integrated project including WASH. So, in such project, we need to provide the total budget of project or only mentioned the budget of WASH component?	In such case, mention the budget of WASH component only.
8	One NGO Can submit 2 or more cluster?	No. One NGO can apply for only one cluster. This is clearly mentioned in section 2.1 and 2.2 of the EOI documents.

9	Can we submit for only one district out of two districts in a cluster	No. The EoI is for a cluster, not for a district.
10	Please clarify whether only one district team will be formed per cluster as per the proposed manpower cluster	The project team will be formed for a cluster, not for a district. The team will carry out the project activities in all the districts in that cluster.
11	Please clarify required qualification of Human resources	Required qualifications of the key positions are clearly outlined in 4.1 of the EoI form 4.

13	Can we get scheme details with working areas?	At this stage we have just proposed number of schemes to be implemented in each cluster. We do not have further details such as name, exact locations (settlements / Toles), types of the schemes etc.
14	Is there any confirmed municipalities in each cluster?	This is answered in question in S. N. 1 above.
15	In EoI form – 5: Document submission checklist (page 23), it mentioned that fill up the check list below and mark (P) Yes/No and submit those documents with the EoI. Shall we need to write P for yes/no?	Writing (P) or using a tick mark () is acceptable. The tick mark was actually replaced by (P) during the document formatting process.
